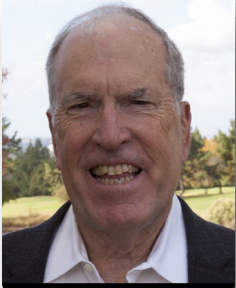

We continue to monitor messages from State Sir, Contra Costa Health Services and policy from the Governor for actions that affect Sir Branch 146 activities.**

Usual news: While the March luncheon was cancelled, the Branch Executive Committee was able to meet earlier in the morning on March 12<sup>th</sup>. Some highlights of the meeting follow. Our Treasurer reports solid cash balances in our Treasury. Little Sir and our Secretary attended a State training event and reported on it.

Our new ride program has received several volunteers who are willing to drive SIR members to our luncheon meetings. However, because of the uncertainty, we did not have any members asking for the service to attend the eventual cancelled March luncheon.

Our Activities Chairman reported that the Table Tennis activity is ready to start now that we have a location for those games. Let's hope it is not too long before play starts.

Since the March luncheon was cancelled, the BEC is looking into how Annual Luncheon Payers will be reimbursed. Ideas were discussed; however, the item was tabled since we don't know how many more luncheons will be cancelled.

### Little Sir's Corner Richard Hockenbrock

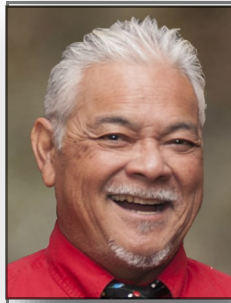

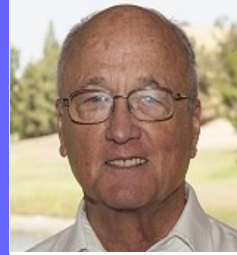
How quickly our world has changed! At this writing I would have been reporting on our greatly anticipated event that was scheduled for March 23 at the Burma Unique restaurant in Walnut

Creek. The dinner was so popular that we actually had 86 diners signed up and had added a second evening, on Tuesday March 24<sup>th</sup>. The dinner was going to include an appetizer, the Burmese tea leaf salad, and five different unique entrees that would have been enjoyed by all. This would have been our most successful restaurant dinner in the seven years that we have had this activity.

The site will be near the town of Manchester in Mendocino.

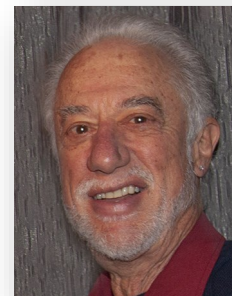
Part of the drive will be on Hwy. 1, but we will be careful and not wipe out too many other cars on the sharp turns.

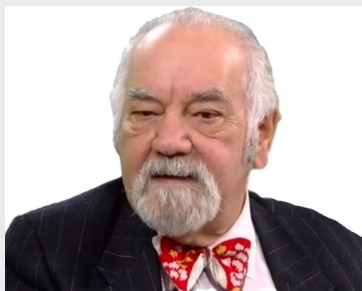
## Travel Milt Smith

## Black Diamond Mine Tour

May 18<sup>th</sup> 10:00 in Antioch



These mining operations were a colorful past history and an integral part of California's economic development after the Gold Rush and was instrumental in California's economic growth in the mid to late 1800's.



**Coal Mining:** From the 1860s through the turn of the last century, five coal mining towns thrived in the Black Diamond area: Nortonville, Somerville, Stewartville, West Hartley, and Judsonville. As the location of California's largest coal mining operation, nearly four million tons of coal ("black diamonds") were removed from the earth. The residents of the mining towns were from all over the world, and their life was characterized by hard work and long hours. Occasional celebrations and a variety of organizations and social activities served to alleviate the drudgery of daily existence.

**Sand Mining:** In the 1920s underground mining for sand began near the deserted Nortonville and Somerville townsites. The Somerville mine supplied sand used in glass making by the Hazel-Atlas Glass Company in Oakland, while the Nortonville mine supplied the Columbia Steel Works with foundry (casting) sand. Competition from Belgian glass and the closing of the steel foundry ended the sand mining by 1949. Altogether, more than 1.8 million tons of sand had been mined.

This an outstanding opportunity to comfortably enjoy a walking tour of a mine in safe, well-lighted environment. Tour participants take a 1309-foot walk into the mine to see mine workings, ore chutes, the shifter's office, and ancient geological features. For safety reasons, you may tour the mine only as part of a guided tour. The tour will last about 90 minutes thru the mine.

After the tour we will proceed for lunch to the **Smith Landing Seafood Grill on the river at the Antioch Marina located at 1 Marina Plaza, Antioch.** **Parking is FREE at the entrance to mine. There are only 32 spaces available on this Private Tour so sign up early. 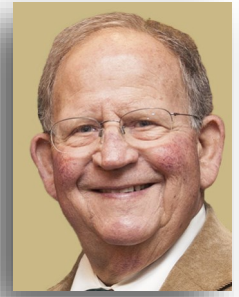

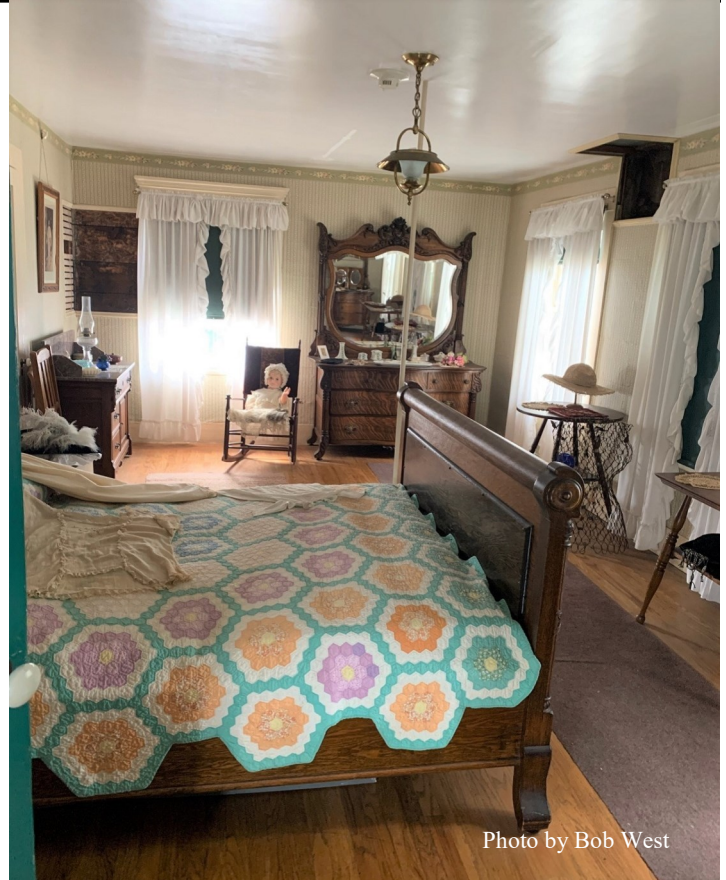

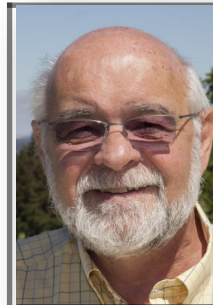

**No further games are now scheduled until the "shelter in place order" has been lifted.**

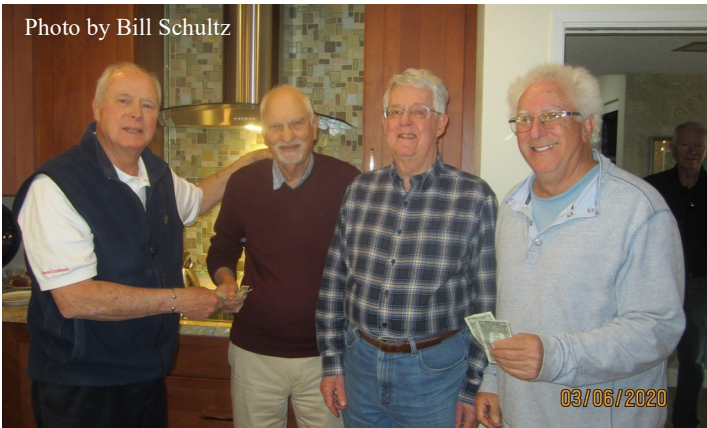
