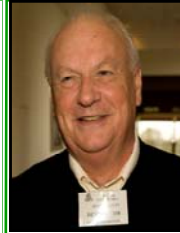

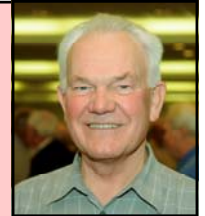

In July we had a tour of the newly-opened Catholic Cathedral in downtown Oakland, The Cathedral of Christ the Light. This building replaces the cathedral damaged in the Loma Prieta earthquake. Proper restoration of the former cathedral was deemed to be impractical and too expensive.

Our tour was lead by a docent who is a SIR in San Ramon. This is a very striking structure designed by a local firm, encompassing the latest in earthquake-resistant design, and uses air drawn in and "stored" at night to cool the building during the day. The perimeter of the main sanctuary has several small chapels.

We dined at the nearby Terrace Room in the Lake Merritt Hotel, overlooking the lake. Formerly a hotel, but now a retirement community. This hotel was **Jim Todhunter's** temporary home when he moved here from the east to take a new position as he waited for his family to arrive.

On August 27, we will be going the Palace Hotel for a tour and lunch in the famed Garden Court. The lunch will be \$19.09, in honor of the hotel's 100 years of being open after rebuilding following the 1906 earthquake and fire.

Our outing on September 24 is now planned for the Pardee House and Estate in Oakland.

Courtroom Drama is SIR 146 Theatre event

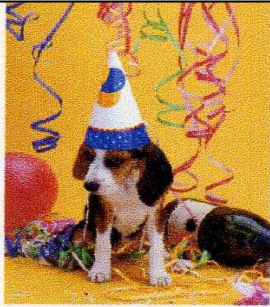

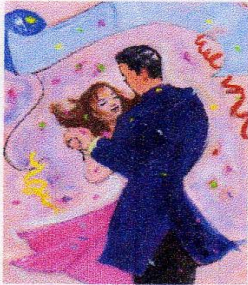
